

## **Professor Weissbrodt's Files: Topic List**

Professor Weissbrodt's Files, a collection of personal documents from his work in the field of human rights, are accessible to those researching an assortment of topics. The documents include, but are not limited to, UN publications, NGO materials, speeches, and notes. The University of Minnesota Law School's Human Rights Library also includes UN publications, books, and articles on the subject of human rights. The documents date principally from 1975 when Professor Weissbrodt began teaching until 2005 when many documents became available online. **Professor Weissbrodt's documents are in file cabinets on the third floor of the University of Minnesota Law Library near the Human Rights Library and must be accessed by key. Professor **David Weissbrodt** established the University of Minnesota Human Rights Center and helped launch the University of Minnesota Human Rights Library online (<http://www.umn.edu/humanrts>). The online database has over 65,000 human rights treaties, jurisprudence, and other core human rights documents translated into Arabic, Chinese, English, French, Japanese, Korean, Russian, Spanish, and Swedish. Both the Center and the Library provide students and human rights advocates access to key documents and online sources concerning human rights.

Professor Weissbrodt is a distinguished and widely published scholar of international human rights law. He teaches International Human Rights Law, Administrative Law, Immigration Law, and Torts at the University of Minnesota Law School. In 2005 he was appointed as the first Regents Professor at the Law School. Since 1998 he has been the Fredrikson and Byron Professor of Law. He was the Briggs and Morgan Professor of Law for 1989-97 and the Julius E. Davis Professor of Law for 1985-86.

Professor Weissbrodt received his B.A. from Columbia University and also attended the London School of Economics. He received his J.D. degree from the University of California at Berkeley (Boalt Hall), where he was a Note and Comment Editor of the California Law Review and a member of the Order of the Coif.

He joined the University of Minnesota Law School faculty in 1975 and has been a Visiting Professor at the Université Jean Moulin in Lyon, France; the Graduate Institute of International Studies in Geneva, Switzerland; Kellogg College, Oxford University; the UN University in Tokyo; and the Monash University Law School in Melbourne, Australia.

He has represented and served as a board member of the Advocates for Human Rights, Amnesty International, the Center for Victims of Torture, the International Human Rights Internship Program, Readers International, and the International League for Human Rights. He remains an active member of these organizations in the Twin Cities.

During 1996-2003 he served as a member of the United Nations Sub-Commission on the Promotion and Protection of Human Rights and was elected Chairperson of the Sub-

Commission for 2001-02. He also was designated the UN Special Rapporteur on the rights of non-citizens for 2000-03. In 2005 he was selected as a member of the Board of Trustees of the UN Trust Fund for Contemporary Forms of Slavery and in 2008 he was elected Chairperson of the Board. He is a member of the American Law Institute and the American Society of International Law, and is on the editorial review boards of the Human Rights Quarterly and the Netherlands Quarterly of Human Rights.

Professor **Marsha Freeman** has also generously included some of her files in the collection. These files focus primarily on the Beijing Conference on Women's Rights in 1995, but include a number of other women's rights-focused documents.

Professor Freeman, PhD, J.D., is a Senior Fellow at the University of Minnesota Human Rights Center, where she is Director of International Women's Rights Action Watch (IWRAW). She is also an Adjunct Professor of Law at the University of Minnesota Law School, where she teaches courses on women's human rights and the UN human rights system.

Professor Freeman is an internationally recognized expert on the UN Convention on the Elimination of all Forms of Discrimination Against Women. She has published numerous articles, reports, and technical papers on the Convention's content and procedures. Professor Freeman is the primary editor of *The UN Convention on the Elimination of All Forms of Discrimination Against Women: A Commentary*, (Oxford University Press, 2012). Additionally, she is the author of *Women's Economic, Cultural and Social Rights*, a manual for using the International Covenant on Economic, Social and Cultural Rights to advance women's human rights.
